SUMMARY SCIENTIFIC PROGRESS REPORT PREPARED FOR THE EXECUTION OF THE PROJECT IN 2016

The research was conducted through a combination of individual and collective efforts of the team. Monthly team meetings were organized to assess progress in research of each team member and any difficulties encountered.

After analyzing the functional approach, realized in 2015, by showing the synthesis of formalistic approach of Dongoroz and Welzel's finalism in Contemporary German functionalist theory, the research conducted in the project opened up the prospect of a prerequisites for overcoming differences in perspective. The constants of (criminal) law and the normative identity of (Romanian) society are treated through the relationship between society and state. From the opposition between Carl Schmitt and Mircea Djuvara one can infer the impossibility of solving the relationship between the constants of law and the normative identity of society. The problem is solved through emphasizing the nature of constants of law as historical concepts, and its signification changes according to different eras, according to Kirchmann and Savigny.
